1. Collection of Your Personal Information

- All participants agree that no data, results, and materials for use in the Workshop will be disseminated by means of publications, reports, or any other form without the express written consent from the AKC, IISPP, and UIC of which these products, data, results, and materials are its exclusive property.
- The AKC, IISPP, and UIC reserve the right to update and change information on the Workshop without further notice.

3. Code of Conduct
